Energetic Economy and renewable sources, what future, what prospectis

The developmental stage at which humanity has reached in this first part of the third millennium has brought a level of science and technology than ever before. This has ensured that it would create a near-**total** domination and **exploitation** of natural and energetic resources on the planet.

Only in recent decades have begun to understand how this situation can not be more sustainable, both for the **ecological balance of the planet** for the **survival of humanity itself**. In this logic must therefore be considered very important incentives for the diffusion of **photovoltaic systems** for energy production and **transport powered by electricity**, combined with a greater focus in the use of **waste differentiated collection**, three key points for a real and effective policy aimed at energy saving.

- As **first** point, the panels of photovoltaic cells, more and more installed on the roofs of homes, schools, hospitals and public administration buildings, they will prove successful tool to produce both electricity, creating the perspective of the **vast electric power station over the territory**, and heat for domestic use, allowing it to reduce emissions of CO₂ from existing thermo-electrical station and thermal conditioning systems excessively popular in recent years in our city.
- As a **second** point, an ever-expanding use of **electric-automobiles**, by building a **network of charging stations** in both cities and along the roads, not a little contribute to reducing the harmful emissions into the atmosphere. In the best way to bring in the technology of **electric motors**, these should be **installed** not only on cars but also and especially on **commercial vehicles** used for transporting goods, such as **TIR** and **vans**, and **public transport**, not only **buses** but also **ships** and **airliner**, which are major contributors to air pollution.
- As a **third** point, finally, more and more conscious use of **separate collection of waste** can lead to **big savings** and **less use** of **raw materials** in various industrial products, could also make use of non-recyclable waste for **further energy production** through the use of modern **incinerators**.

In conclusion, it is clear how the **scientific and technological evolution** that has gone humanity

on the brink of environmental disaster, it also is, fortunately for us, the only means to create a **better future** for generations to come, if, of course, we awareness and the resolution is necessary in all of us.

Manifesto for the European Renaissance

Preamble and programmatic line of the new pan-European political movement

Europe has its **roots in common**, must not forget its **history**, should no longer delegated its destiny to others. Europe must be the **Union** of its peoples as a great and strong centuries-old tree has its roots in the land, but stretches out his long arms toward the infinite sky.

Highlights of our program:

- Create a **only European Army** within NATO could become a weight equal to the U.S., increasing global stability.
- Unify the judicial system to create a truly **European system of federal courts**.
- Creating a truly **European Federal Police**, which has jurisdiction throughout the Union. (E.B.I. = European Bureau of Investigation).
- Creating a truly **European border police force** that can be monitored regularly, by appropriate means, the long borders, especially along the southern coasts of the Mediterranean.
- Create the **Federal Senate of European Regions**. In addition, some members of the European Parliament will be elected in **supranational lists**.
- Creating the conditions for genuine **economic integration of national markets** into a single

- European structure that goes beyond the single financial integration.
- Introduce the **Eurobond**, on which model of the Euro money, gradually replacing the emissions of domestic securities. Distributing the funds raised in part in percentage depending on the economic importance of each member state, in part as **federal investment fund** managed by the Union.
 - Promote a growing **political and social integration** that the various political organizations and unions to evolve from domestic parties united in the European federations to real entities that act on the European territory with national branches.
 - **Valuing European symbols** like the **Flag** and the **European Anthem**, set up a real **Feast to celebrate the European Homeland** as holidays in all European Union countries.

The program points you just read is only **the beginning of our project** just started and still under construction.

We aim to create a **movement rooted in the territory**, able to influence government decisions, from local to national, to arrive at the birth of a true **European Federal State**.

So we decided to found the **Movement for the Federation of European Peoples – MFEP** with which we can achieve the goals listed above and bring Europe to be the center of economic social and cultural regeneration of the world in the twenty-first century.

The return of global Polis's direct Democracy in the digital connection Era:

The Virtual Assembly

Arrived early in the second decade of the twenty-first century can be seen increasingly as the **traditional representative democracies** in the industrialized countries are moving towards a **progressive deterioration**, mainly due to the increasing disaffection of citizens to political participation manifested mainly in a progressive increase of **electoral abstention**.

This in turn is due to the now **unbridgeable gap** formed between the **ruling political class** and the electorate, which tends increasingly to see first in a **caste of privileged** that self-perpetuating almost parasitically trying to manage public affairs as a his private business, without taking into account the real needs and demands of civil society, if not showing a semblance of interest in the latter only for **electoral purposes** only and consensus through the usual promises, then invariably not maintained, and the ostentation of impalpable and generic **programs** vaguely reformist **used propagandistically**.

But now the **technology** that so much has been developed in recent years, can help almost providential to the **need for real political participation** by the younger generation to which they aspire, reviving direct democracy in force at the time of **classical Athens**.

At that time the citizens of the Greek **polis** could **participate directly** in community decisions by meeting regularly at the assembly. But this was possible mainly due to the relatively small number of citizens themselves. When the progressive formation of more and more governmental entities and the consequent increase of the population they contain the method of direct democracy was abandoned, this was replaced the first with forms of representative democracy, then with oligarchies, to arrive at forms of monarchy more or less than absolutist mold.

Only in the last two centuries and a half has seen the return of **democratic forms of representative** from 700's revolutions, the American first, then the French, even to the **current presidential or parliamentary republics** now present in almost all over the world. But such democratic forms are increasingly showing their limitations especially with regard to the ability to grasp and realize the true expectations of the people subject to them.

But now finally **direct democracy can rise** through the development of **digital interconnect technologies** are increasingly penetrating in developed societies, thus overcoming the main problem of the huge number of citizens, the millions, which until now had prevented the creation of a **permanent assembly consists of all adult members of the state**.

By now, the widespread diffusion of **mobile telephony network**, with new equipment of last generation, creates a near-total interconnectivity between citizens, allowing **real-time virtual creation** that assembly of all the people peculiar to Athenian era's direct democracy. Creating special programs (software) designed to operate safely over the mobile network and ensuring the authenticity of the will expressed by the citizens, you can arrange a **“Virtual Assembly”** with a voting system that quickly and efficiently through the various terminals laptops can **permit every citizens to participate in parliamentary practice**, allowing it to be a leader in the formulation and approval of the legislation. All this of course to all levels of government, from local up to national and supranational.

This will lead to the **overcoming of the systems of parliamentary representation**, bringing the same electorate to hold the prerogatives of the **legislative power**. You only have to maintain a **coordinating organ** made up of a select number of individuals, legal experts and the various

branches of human knowledge, able to **direct** the input information, **coordinating** the bills and **guaranteeing** the purity and legal consistency.

Will remain inevitable **permanence of a governmental structure** to another guaranteed in its functions by the confidence granted by the majority of “**Virtual Assembly**”, the more streamlined and efficient as **no longer bound by old party-dominated rules** of division and its high numerical components, but consists of a small circle of members selected from various individuals, proposed by a significant number of citizens, recognized for their special capacity from the same components of “**Virtual Assembly**”. All this **beyond the current logic of politics** increasingly influenced by **lobbies of power** often hidden and can not be controlled by public opinion.

This new system of direct democracy, completely eliminating the current separation between the ruling class and the people governed, it will lead to a **qualitative leap forward**, socially and politically, on a scale never before seen in the long history of humanity.

A government for a united world:

the 5 levels of world federalism

The world at the beginning of the XXI century is in a paradoxical situation in which the **economy** and **finance** become **globalized** increasingly expand beyond the old divisions imposed by the boundaries of countries and out of control of the same nation-states. The latter with its own laws or delegating supranational organizations with a regional or continental dimension seek to impose **rules** and **controls** often **insufficient** to create a network of legal and social protection designed to make the market more equitable and sustainable from an economic profile, from global environmental protection, and from the social and cultural progress of humanity.

The recent **imbalances** and the resulting **economic crisis** of individual states are also caused by this lack of global order mainly due to the **absence** of a **world government body** that can **legislate** on economic, financial, fiscal, environmental subject. A true world government democratically elected to impose its will and **counter the dominance of multinationals** and large **economic and financial powers** more and more prevailing and able to exploit the gaps and differences in legislation between countries.

The process in recent years is taking place in various parts of the world towards **regional and continental unions** of countries aimed at standardizing the legislation and regulations in force in them, such as the **European Union**, **NAFTA**, the **African Union**, **ASEAN**, **Mercosur** and other organizations, is still too slow and weak to keep up with the demands imposed by financial markets and economic development, which require clear and equal rules for all.

Unfortunately, the slowness and weakness of this unification process is often imposed by increasingly share of public opinion in their respective countries that listening to the **populist and nationalist sirens** of hostile movements to the process itself can convince themselves that remain clinging to **old national patterns** born in the XIX century is the solution to the problem of unemployment and the degradation of their society. As a result is imposed their governments a defeatist attitude and not very courageous towards unitary path. By doing so, these groups do not realize the opportunities that you are missing out as the chance to live in a world more united and in solidarity.

The same process of unification has various **problems**, such as **decision-making method** in legislative reform and adoption of international treaties focused on **intergovernmental meetings** that is often viewed negatively by the same public opinion, considering it an undemocratic method, or the **lack of communication and propaganda** the same continental organizations to propagate their ideas and initiatives between the populations concerned, and for this they feel not involved and players in the unitary process.

At this point, the process of unification can grow efficiently only if it relates to a **democratic and federalist vision** that involves all the social components of the various peoples. An **Federalism to 5 levels**, that starting from the lowest it can canalizes the economic and social energies of the various territories toward a global unification of the states.

The 5 optimal levels of the **World Federal System** are:

1. the **urban commune**
2. **Administrative Region**
3. the **nation-state**
4. **Continental state**
5. **world government**

This division optimizes the public government in a increase of responsibilities and tasks, starting from the lowest level of the **urban commune**, who focused his administration on the maximum **relationship between rulers and ruled** for solving everyday problems.

To move to the **region**, that with a comprehensive view can better **coordinate** local development policies and social and health policies.

While the **national state** can impose the necessary steps to the **overall development of the social and economic tissue** of the nation as a union of citizens joined by a common culture and tradition.

The **continental state** should be seen as a **link between the different states** for all the economic and social initiatives marked the **development of networks and infrastructure**, but also policies on the free movement of property and people and the promotion of ideas aimed at overcoming the old national lines.

Finally, a only **world government** which, with its imposition of a **global power**, higher than any other state associations, subordinate to it, can impose laws and regulations are necessary for the economic and social controlled development of the planet by **eliminating** the root factor the same conflict between states, mainly due to a **poorly distributed wealth** created by the exploitation of resources on the part of some states to others. Result of this global power will be the **elimination of national armies**, replaced by the police forces, and the establishment of a **small but efficient world army** act to protect the people from any local conflicts.

The world government will have to be accompanied by a **planetary Congress** elected democratically by the people of the Earth, which poses a political control of the government itself and prevents authoritarian tendencies.

Such a **World Federal System** is the only solution that will bring humanity to the prosperity and awareness of their own means and limits have not yet been reached after thousands of years of so-called civilization overshadowed by conflict and destruction.

Tool for a more united Europe:

The Standard European Language (SEL)

The **world**, increasingly **interconnected and globalized**, requires a language that allows communication between different peoples, but that does not go at the detriment of the cultural plurality of the same; then a standard language must necessarily accompany and not a substitute for national languages, overcoming the current situation in which a language, English, hegemonising and contaminating other languages.

But because of the linguistic diversity of the various regions of the world very marked, it is virtually impossible, in the present state of cultural integration between the peoples of the Earth, you can create a standard language understandable and acceptable to all terrestrials. But this problem can be overcome in specific areas of the world, such as **Europe**, where the historical and linguistical events led to the birth of languages more or less related to each other, almost all belong to the great Indo-European language family.

Moreover, the process of unification of economic, political and social in recent years has tried to advance in Europe suffers the lack of an indispensable tool as would be the use of a **single target language** that can complement, and in community assemblies as the Parliament and the European Commission to replace, the expensive and slowing use of the single national languages.

So the birth of a **Standard European Language (SEL)** is highly desirable as it may be both **cause** and **effect** of same political, social and cultural **integration** of Europe, while bringing its citizens, while remaining anchored to their linguistic and cultural specificity, to acquire a new and profound **sense of belonging** to a larger community to identify with the **European Union**.

For this it is necessary that the **European Parliament institutes** and funds, with the support of all European Union countries, a **special organism** composed of leading **linguists, semioticians** and scholars in related subjects with the task of creating this **SEL**. An institution thus established will follow **criterion of convenience and simplicity** trying to build a linguistic system as much as possible similar to the way of thinking and talking the peoples of Europe.

Taking as a basis the structure of Indo-European languages, you must create a **simplified and rationalized grammar** that he will be accompanied a **vocabulary of simple and easy to learn**, that will be formed taking into account a criterion of **comparative etymology**, for which the individual words must, in their morphological and syntactic construction, reflect closely as possible the meanings (semantic area) of greater use of their words in national languages, so to **facilitate** the **understanding** and **learning** both culturally both on a practical level.

In creating the **SEL** will have to take account of its **utilitarian value as a means of facilitating economic, social, cultural** and as a stimulus for the interchange between the peoples of Europe. So you will not create a perfect language, moreover a purpose than in centuries past you tried to reach several times but in vain, but a **language easy and functional**, also susceptible to future improvements, keeping in mind a structural basis that goes preserved over time.

With the necessary **political support of the Community institutions** the **SEL** thus created may make use of a **capillary and concrete diffusion** through courses for youth and adults established in **schools** of every order and degree, in addition we will take advantage of the use of media (**TV channels, radio, newspapers, Internet portals**), both existing and specially created, that broadcasting **contents in SEL** will allow an additional spread throughout the European population.

Will be noted in the **teaching of SEL** the **concept** that it is created to **make it simple and immediate understanding between interlocutors by different mother tongue**, so its equidistance from national languages should be maintained as much as possible to avoid losing its reason for

being and not become one of the many existing languages or worse risk, through contamination and barbarization, to expire in a pseudo-dialect with differences in pronunciation and syntax of a regional nature. So it is important that it is treated as an **exact language**, as are many symbolic languages, the mathematical, musical one, Morse code, Braille, which for this are recognized and used worldwide and can not be altered in their form as not to lose meaning and utility.

Therefore, the **maker institution** of the **SEL** will **supervise** its **integrity, evolution and future modifications** so that the language stays at a stage that enables it to remain a **neutral instrument of interlingual communication**, without compromising its **evolution in the sense of art and literature**, which indeed will contribute to its **further spread and affection** among the population.

We are aware that the task set out to create and disseminate the **SEL** will be costly, both in economic terms and in the cultural, and require a not certain short period, but only by following this path you will come to a **degree of social and cultural integration** sufficient to **consolidate the construction of the European Community** and consequently bring **Europe** to a level that would allow to **compete on the world stage** with other major economic and linguistic areas as the U.S.A., China, India, which increasingly are constituting the economic and cultural center of the world at the beginning of the twenty-first century.

Proposed reform of the electoral law for the election of the Chamber of Deputies and the Senate of the Italian Republic

The **current electoral law** is now considered by many as **inconsistent and not suited** to fully express the will of the people, being those unable to choose candidates directly, both in **ensuring a unique and undisputed majority** in parliament because of the different method of allocation of seats in force between the Chamber and Senate. Furthermore, it requires a reduction of the elect to bring a saving of expenditure policy, without prejudice to the maintenance of an adequate representation. This is a new electoral law must solve these **three problems**.

First, in the logic of a federal system in recent years is going progressively rising, we must **abandon the perfect bicameralism** which until now has characterized the parliamentary structure with the establishment of a **Federal Senate of the Regions and local government** elected with **second degree consultations** subsequent to the election of regional assemblies reflecting so the its political composition. The new Senate so elected will serve as a place to legislate and redeem disputes in connection with matters of a local nature. So the federal Senate will **not be called to put more confidence** in the government and vote the laws of national character, only tasks left to the Chamber of Deputies. However, the Senate will be called to **approve international treaties** after the approval by the Chamber.

Second, will be returned to the preferences in the election of the Chamber of Deputies, giving full power to the voters to express both towards a policy list and a specific candidate.

Finally, **third**, the reform provides for the **overall reduction of the representatives of the people**, bringing the elect to the **Senate at 200** and for the **Chamber at 500**.

Election of the Senate:

The **Federal Senate of the Regions and local governments**, as mentioned above, will be elected in **elections of the second degree** by regional councils, after the renewal of the same and then **hooking the election of the Senate in the regional elections**. The distribution of seats will be made according to the **formula of 60/40**, i.e. assigning senators to 60% of the majority and the remaining 40% opposition on a regional basis. The total number of **elected representatives in the Senate will be 200**, prorated between the regions by assigning one every 300,000 inhabitants, according to the diagram below.

Election of Chamber of the Deputies:

As part of the abandonment of perfect bicameralism, as stated at the beginning, **will be the only Chamber of Deputies to express confidence in the Government** and approval of most legislative proposals, leaving the Senate only formulation and approval of those regarding the matters their regions and local authorities.

The Chamber of Deputies shall be composed of 500 members.

The principal novelty of this proposal for electoral reform is based on the method chosen for the election of the Chamber of Deputies. Without prejudice to the **reintroduction of preferences** will be **introduced a double round on a proportional basis** to ensure greater political representation can without, however, prevent the formation of a solid majority by the coalition or single party resulting winner.

The **first round**, which will be called for the **Election for the Representation**, elect **50 deputies**, so that each party will have exceeded **2% of the votes** of scale National will be entitled to elect to meet the quota comply with the relevant percentage achieved. There will be no distinction between parties occur coalesced or individually. However, if in a coalition several parties did not reach the quorum of 2%, the sum of their votes will go to added to that of the parties of same coalition that have passed the quorum in proportion to the electoral weight of these parties within the coalition itself by helping to increase their share of the vote and thus elect.

In the **second round**, called the **Election for Governance**, which will elect the remaining **450 deputies** will compete the **two parties or coalitions of parties** who have obtained the **highest number of votes** on a national scale **in the first round**.

Even in the Election for Governance will be applied to the **formula 60/40** for which the party or coalition of parties in the second round will 50% plus one of the valid votes shall be entitled to elect 60% of that added to the elect of the first round will form the majority, the party or coalition party came second will have the remaining 40%. The **allocation of seats will include all the parties of the coalition in the first round will exceed 1% of the vote**.

To make it more streamlined and light as the voting **preferences to determine the elect will be expressed only in the first round of voting**; Therefore, the lists of individual parties already contain a sufficient number of candidates to cover the entire amount of 500 eligible. In the **first round** will be **elected the candidates** who obtained the **greatest number of preferences** within their list. In the **second round** you should not express, the voter, no preference but **only indicate the party or coalition chosen**, elected in the second round will be the stand as a candidate in that scale will have won more votes in the first round after the first electies.

To clarify the proposed new mechanism in this reform is shown below a **simulation** that is based on the **results of last elections 02/24-25/2013**. (Source: Website of the Ministry of the Interior)

As you can see from the table above with the electoral reform proposal would have a **clear majority** in the last election, in this case, the center-left, obtained by a clear vote and legitimized by the voters **in the second round**, while ensuring a **fair representation for minority political forces** proved both the first and the second round but deserving to be able to compete with their seats to a serene and constructive opposition in the parliamentary life of the legislature.

In contrast, the current electoral law gave disproportionately victory to a political line-up strong of only a small majority of votes, not supported for another by the same response to the Senate because of the known distortions regulations, thus eliminating the possibility of establishment of a solid quickly and fully legitimate government.
